Attorneys Are Powerful Allies for Health

POVERTY IS BOTH A CAUSE AND CONSEQUENCE OF POOR HEALTH. WHEN DOCTORS PARTNER WITH LAWYERS, SOCIAL AND ENVIRONMENTAL CAUSES OF ILLNESS CAN BE ADDRESSED AND IMPROVED.

De'Shae's asthma has worsened to the point of becoming bronchitis. Not only is she suffering, her four-year-old son is also coughing and struggling to breathe.

While their symptoms can improve with medical care, Dr. Rishi Manchanda says we must "look upstream" to understand the environment in which people live and how it affects their health and everyday lives.

If De'Shae and her son are only treated for their symptoms, no one would ever know that black mold is infesting their

rental apartment. According to De'Shae, it's making them very sick.

Without money to move, or a landlord willing to correct the problem, this family needs a rather unexpected person as part of their health care team: a lawyer. Pisgah Legal Services has taken their case.

Manchanda says that medical professionals can learn to identify social and environmental determinants of health, and then partner with organizations like Pisgah Legal to provide more holistic care.

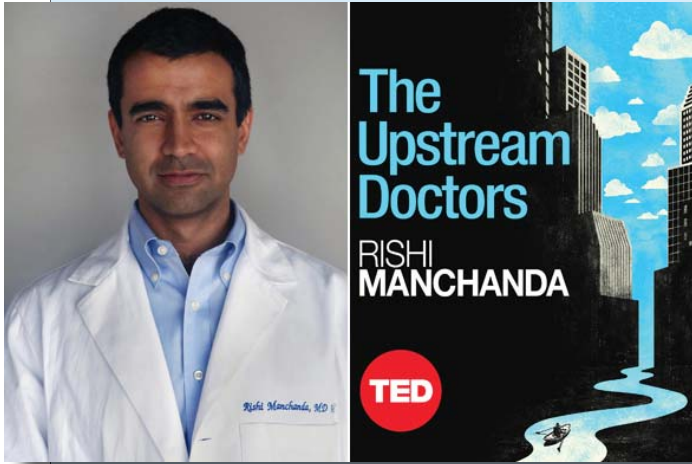

About Rishi Manchanda

Dr. Rishi Manchanda is an "upstreamist" physician and public health innovator. He focuses on improving primary care, the social and environmental conditions that make people sick, and health and human rights.

Manchanda is founder and president of HealthBegins, a social enterprise that seeks to transform health care. He serves as the medical director of a clinic for homeless veterans in L.A.

Manchanda is also the founder of RxDemocracy, a nonpartisan health care coalition that supports civic engagement and that has registered 30,000 voters in clinics nationwide. And he is the author of "The Upstream Doctors."

Last year, Manchanda was chosen by *The Atlantic* as one of 20 leading health care innovators in the U.S.

HEALS: A Successful Medical-Legal Partnerships in WNC

The Health Education and Legal Support Project (HEALS) is a medical-legal partnership between PLS and Mission Hospitals that began in 2006. It was the first of its kind in the state of North Carolina.

Since then more than 2,600 low-income people have been helped through HEALS, and thousands of medical

professionals have been trained about the underlying social determinants of health.

Mission doctors and staff regularly call upon PLS attorneys to assist patients with end-of-life planning, access to Medicaid and disability benefits, legal intervention in unlawful evictions or foreclosures and protective orders for victims of domestic violence. Pisgah Legal hopes to expand this successful program into other parts of WNC.
