Family Finds New Home for the Holidays

Like thousands of other people in our region, Elizabeth and Dwayne were paying a lot of rent money for a house with serious problems. Theirs had sinking floors and foundation, a roof that allowed rain water to pour in, and a bathtub that was close to falling through the floor.

Not only did their landlord refuse to fix the problems, he tried to raise their rent. When they said no and tried to negotiate for repairs, he moved to evict them, a practice Pisgah Legal attorneys see all too often.

The family came to Pisgah Legal Services. Attorney Molly Maynard stopped the eviction, gave them time to find a better place to live and helped them avoid homelessness. They will now celebrate the holidays in a much better home where they feel safe. Elizabeth says they are so grateful – not just for the legal help – but also for the way they were treated.

"There was no judgment towards me or my family because of our income. Pisgah Legal is an organization that truly does care about people and their problems."

First the good news! This year we have several new projects

to tackle problems of poverty and injustice in our region. Through the "CLASP" partnership with Vaya Health, we are helping people with mental, physical and developmental disabilities move out of institutional settings and live independently.

Without an attorney to advocate for these clients, many of them would have no path out of unsuitable group homes and other institutions.

We are thrilled to have new partnerships with the Mediation Center, Safelight and SAFE to help stop child abuse by securing legal custody for children with a safe parent or guardian.

Pisgah Legal Services recently received two new grants from the NC Interest on Lawyers Trust Accounts, one to work on community economic development to improve housing and job opportunities, and a second to prevent low-income home owners from losing their homes to foreclosure.

Through innovative programs like these, Pisgah Legal helps more than 15,000 people each year. But in the current climate, many of our clients are scared of what the future holds.

We remain steadfast and committed to providing equal access to justice for our clients, to help protect them from the ravages of poverty and abuse. As MLK, Jr. reminded us, "The arc of the moral universe is long, but it bends towards justice."
