

Struggling to Avoid an Unfair Eviction

LAST YEAR, PISGAH LEGAL SERVICES HELPED ALMOST 3,000 SENIORS, INDIVIDUALS, VETERANS AND FAMILIES WHO WERE ON THE VERGE OF BEING HOMELESSNESS.

The word eviction has a very straightforward definition: "The removal of a tenant from rental property by the landlord." But circumstances surrounding an eviction are often anything but simple, and the effects of an eviction can send a person or family spiraling into poverty.

Pisgah Legal volunteers and attorneys work every day with people in Western North Carolina who struggle to avoid eviction, foreclosure and other housing crises. All of these clients faced evictions:

- Robert, a retired veteran whose complained to his landlord that sewage was backing up into his basement.
- Carrie, a domestic violence survivor and mom of three whose ex husband became violent when he dropped the kids off at her new apartment.
- A family of four who learned their rental house was being condemned by the City; they had only 30 minutes to pack and

A Focus on Housing

At this year's forum, Desmond and local housing leaders will discuss the urgent issues of eviction and decent, affordable housing in our mountains.

Desmond will also speak on Sept. 29 at a free **Affordable Housing Summit** for

developers, planners, advocates and government leaders to discuss strategies needed to provide better housing in the region.

About Matthew Desmond

Matthew Desmond is a professor of sociology at Princeton University. His primary teaching and research interests include urban sociology, poverty, race and ethnicity, organizations and work, social theory, and ethnography.

His book, *Evicted*, won the 2017 Pulitzer Prize for nonfiction, among many other awards.

In 2015, he was awarded a MacArthur "Genius Grant" for revealing the impact of eviction on the lives of the urban poor and its role in perpetuating racial and economic inequality.

The Scope of the Problem in WNC

- The median rent for a two-bedroom apartment in Asheville is \$1,180 a month, the highest in the state.
- 15,080 = the annual salary for a full-time minimum-wage job.
- In 2015, 15.4 percent of the Asheville metro region population was living below the federal poverty threshold; that's \$25,257 for a family of four.
 - Almost half the people in Buncombe County pay 30 percent or more of their income for housing.
 - The average income of a Pisgah Legal client is \$11,719 per year.
 - Vacancy rates for apartments in WNC have been as low as 1% in recent years.
 - Some parts of WNC have a waitlist of five or more years for public or subsidized housing. In 2016, 1,187 families were on the waitlist in Buncombe County.
- Studies show as many as 57 percent of homeless women in the U.S. report domestic violence as the immediate cause.
- In 2016, Pisgah Legal prevented homelessness and stabilized housing for 2,967 people in WNC.

Pisgah Fights to Replace \$500k+

STATE CUTS CRITICAL LEGAL SERVICES FOR OUR COMMUNITY

Pisgah Legal Services is experiencing extraordinary funding challenges.

This summer, Pisgah Legal Services lost \$535,000 in state funding that was previously designated to provide legal aid to people in need.

On July 1, the N.C. General Assembly eliminated more than \$1 million for legal aid funding across the state. To make matters worse,

funds that once allowed us to assist people with mental health care, disability benefits and housing needs have also been lost due to state cuts.

With a loss of more than half a million dollars, we must do more to replace funds and preserve vital services. Otherwise, more than 2,800 local people could lose access to legal help in the coming year!


This summer Wicked Weed Brewing and the Guthy Family made a generous \$50,000 gift, especially wonderful news
