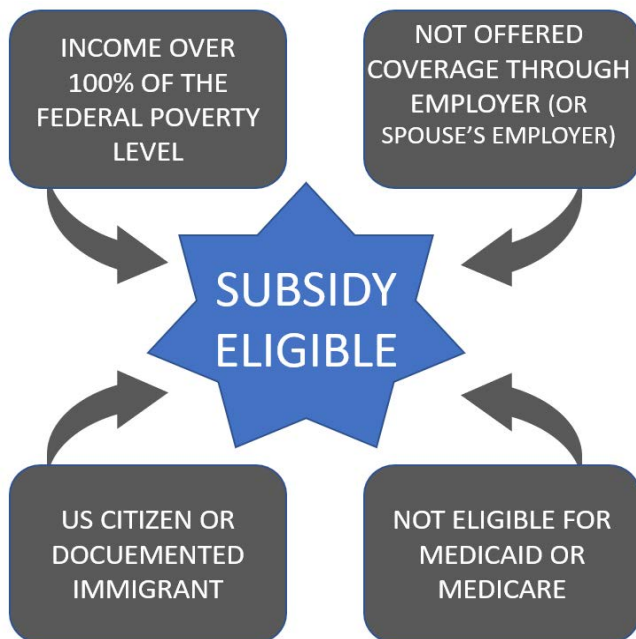

CONFUSED ABOUT HEALTH INSURANCE? YOU ARE NOT ALONE.

- Applying for health insurance on the Affordable Care Act (ACA) Marketplace
- Understanding options for insurance plans, how they work and Medicaid enrollment
- Keeping your ACA plan throughout the year when you are experiencing an issue with your plan and you aren't sure how to solve it

HOW DOES IT WORK?

- To qualify for the ACA Marketplace, you must be a US citizen OR have documented immigration status (except DACA)
- Purchase a plan during enrollment OR within 60 days of a life qualifying event such as:
 - Birth or Adoption
 - Loss of coverage including Medicaid/CHIP
 - Move to a new zip code
 - Newly qualified for subsidies
 - New citizen or lawful status
 - Newly released from incarceration

DO YOU QUALIFY FOR LOWER COST HEALTH INSURANCE?

- To qualify for financial assistance your household income must be at or over 100% of the federal poverty level, except in qualifying circumstances.

1 Person Household	over \$12,880
2 Person Household	over \$17,420
3 Person Household	over \$21,960
4 Person Household	over \$26,500
- Not be eligible for any other health insurance like Medicaid, Medicare or employer-based insurance from your employer or your spouse's employer.
