HOUSING 4,363 people helped to stabilize housing and prevent homelessness



**SAFETY** 6,957 people helped to escape domestic abuse and rebuild their lives



HEALTH 5,532 people assisted to increase their access to health care, including ACA and Medicaid health insurance



INCOME 5,865 people helped to increase and protect their basic income, including free tax aid

### **DAWN'S STORY**

Dawn is a single mom to Trinity, who lives with autism. When Trinity's disability payments stopped, and they were told by the government that they owed thousands in overpayments, they feared they would lose their home trying to pay it back.

Scared and desperate, Dawn reached out to Pisgah Legal Services where attorney Shoshana Barton took on their case.

With Shoshana's help, they contested the overpayment claims and discovered that not only did Dawn and Trinity not owe money, but they were also entitled to more benefits than they were receiving. Trinity's monthly benefits were reinstated and increased, and they received a lump sum back payment of over \$2,000.

Dawn and Trinity also worked with other Pisgah Legal programs, including free help filing taxes and taking advantage of the Earned Income Tax Credit.

Between fixing the original benefit issues and accessing tax credits they didn't know they were entitled to, Dawn and Trinity received over \$10,000 in benefits through Pisgah Legal Services. Dawn is very grateful, especially for the kindness and support they were shown. She says she never felt shamed asking for help, but as if Pisgah Legal was holding her hand, saying, "I got you."


