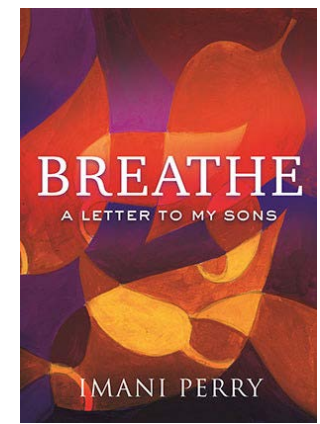
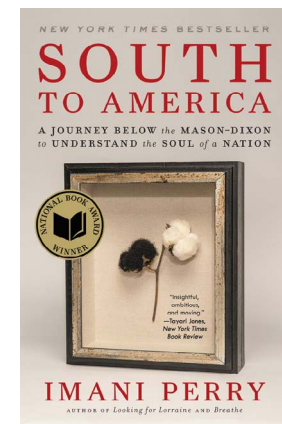
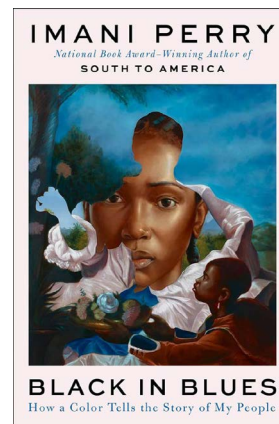


## About the Speaker

A professor at Harvard University and recipient of a MacArthur "Genius" Fellowship, Perry is known for her insightful books, including *South to America*, which won the 2022 National Book Award for Nonfiction.
