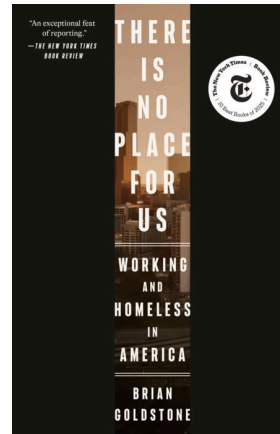

Brian Goldstone is a Pulitzer Prize-winning journalist whose work examines the human impact of housing insecurity, poverty, and economic inequality in America. Through immersive investigative reporting and deeply personal storytelling, Goldstone brings national attention to the challenges facing working families in an increasingly unequal economy.



Goldstone is the author of *There Is No Place for Us*, which won the 2026 Pulitzer Prize for General Nonfiction. His reporting has appeared in publications including The New York Times Magazine, Harper's Magazine, and The New Republic, where he explores the intersection of housing, labor, race, and public policy with empathy and clarity.
